### Section 955.20 O.R.C. Dog Registration / Instructions

*(This application cannot be used for kennel registration)*

The registration fees provided for in sections 955.01 to 955.14 O.R.C. (in part) constitute a special fund known as "the dog and kennel fund," which shall be deposited by the county auditor in the county treasury daily as collected, and be used for the "purpose of defraying the cost of furnishing all blanks, records, tags, nets, and other equipment, for the purpose of paying the compensation of county dog wardens, deputies, pound keepers, and other employees necessary to carry out and enforce O.R.C. sections (in part) 955.01 to 955.261, and for the payment of animal claims as provided in sections 955.29 to 955.38 of the Revised Code, and in accordance with section 955.27 of the Revised Code."

The board of county commissioners, by resolution, shall appropriate sufficient funds out of the dog and kennel fund, not more than fifteen percent of which shall be expended by the auditor for registration tags, blanks, records, and clerk hire, for the purpose of defraying the necessary expenses of registering, seizing, impounding, and destroying dogs in accordance with sections 955.01 to 955.27 O.R.C.

If the funds so appropriated in any calendar year are found by the board to be insufficient to defray the necessary cost and expense of the county dog warden in enforcing such sections, the board of, by resolution so provided, after setting aside a sum equal to the total amount of animal claims filed in that calendar year, or an amount equal to the total amount of animal claims paid or allowed the preceding year, whichever amount is larger, may appropriate further funds for the use and purpose of the county dog warden in administering sections 955.01 to 955.27 O.R.C.

**Please read the instructions carefully. Dogs must be registered by Jan. 31 to avoid penalty.**

Dogs can be renewed by mail, online or at any one of our area vendors (see reverse side for list).

- **To renew online** - take this application for reference (prior year tag number) and go to [www.loraincounty.com/auditor](http://www.loraincounty.com/auditor) and click on the **Renew Your Dog License** button. Registering online is fast and easy and saves you from having to pay return postage. You will receive your tags in 3-5 business days.

- **To renew at one of our vendors** - **Take this application with you** to one of our area vendors listed on the back of this form. **Our vendors have changed.** Take this form to the store with you to ensure that your data is correctly maintained.

- **To renew via mail** - Ensure that all the information is correct on the forms below.

**RETURN** along with your payment (**fee schedule on other side**) (check or money order payable to the Lorain County Auditor) **and a self-addressed-stamped-envelope to:**

Your tags will be mailed to you. Applications will be processed in the order in which they are received. Your check will not be cashed until your application has been processed. If you have not received your tags, contact your bank to verify that your check has cleared before calling our office.

**Sec. 955.01, 955.05 O.R.C. requires that a penalty be assessed if the dog license is not obtained on or before January 31, or within 30 days after a dog becomes three (3) months of age; or within 30 days if the dog is brought into the state from outside the state.**
